

Terms & Conditions – Referral Bonus

1. How it works:

- 1.1. Firstly, if you do not have any trading or IB accounts with us, you must **opt-in** from the campaign page <https://www.gomarkets.com/en/lp/refer-a-friend/> and simply **register as a new IB** then you will be able to start referring new clients to trade with GO Markets.
- 1.2. If you are an existing retail client, you are also required to **opt-in** from the campaign page <https://www.gomarkets.com/en/lp/refer-a-friend/> and **register as a new IB** then you will be able to start referring new clients to trade with GO Markets.
- 1.3. If you are an existing IB, you do not have to opt-in and by default you are eligible to this campaign. But you must follow the step below to claim your bonus.
- 1.4. After you have registered as an IB you can claim your Cash Reward each time you reach a Bonus Tier in the above table. You will need to send your account ID and the tier information to support.mu@gomarkets.com to claim your bonus.

2. Terms and Conditions

Terms & Conditions are to be read in conjunction with GO Markets Pty Ltd (MU)' General Terms & Conditions and Disclosure Statement.

- 2.1. This promotion will run between 12th July 2021 and 30th September 2021 only. Any clients referred or volume traded after the 30th September 2021 will NOT be counted towards this promotion.
- 2.2. Any IB who opt-in this referral bonus campaign is eligible to one Cash Bonus per Tier and can't claim more than once in the same tier.
- 2.3. A minimum number of New Qualified Clients is required to be referred to GO Markets to become eligible to claim the Cash Bonus.

- 2.4. Each referral is required to meet the following conditions to be counted as a New Qualified Client:
- Open and fund a GO Markets trading account between 12th July 2021 and 30th September 2021
 - The Client must be a new client to GO Markets, who has never held a trading account with GO Markets in the past.

 - The account must be funded with a minimum of US\$300 (or your account currency).

 - A minimum trading requirement of 3 standard round-turn FX or Metal lots is required to counted as a Qualified Client.
